No existing structure, nor any structure built or to be built in the future, shall be used for purposes of a model home; Notwithstanding any provision to the contrary, the Declarant expressly reserves the right, and shall always have the right, to use an existing structure, and/or any structure(s) built or to be built in the future, as a model home.
