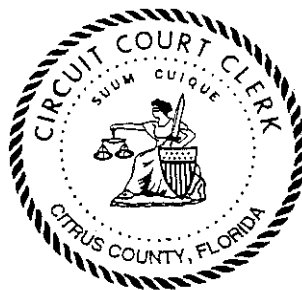

**AMENDMENT TO  
THE DECLARATION OF  
COVENANTS, CONDITIONS AND RESTRICTIONS  
FOR CLUB MEMBERSHIP,  
HAMPTON HILLS**

THIS AMENDMENT ("Amendment") is made to the DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR CLUB MEMBERSHIP, HAMPTON HILLS ("Club Declaration") this 19th day of November, 2002, by Hampton Hills, a Florida general partnership. It more particularly specifies those lots which are subject to the "Club Declaration" recorded at O.R. Book 1196, Pages 1012 *et seq.*, as amended from time to time.

WHEREAS, Developer is the owner of the real property described in this Amendment and the Club Declaration, and desires to create thereon the benefit of social membership in the Citrus Hills Golf and Country Club, and the burden of payment of family social membership dues as established from time to time by Citrus Hills Golf and Country Club, Inc., or its assigns, and to provide for collection of such payments by the Association; and,

WHEREAS, Developer desires to more particularly specify the property subject to the Club Declaration;

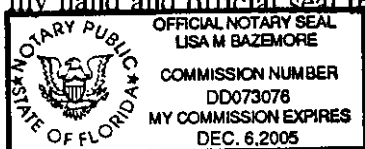
