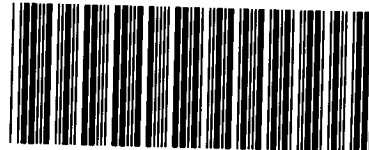

GRANTOR RETAINS THE EXCLUSIVE RIGHT TO BE THE BUILDER/CONTRACTOR ON ANY AND ALL CONSTRUCTION UPON THE PROPERTY FOR A PERIOD OF FIVE (5) YEARS FROM THE DATE OF RECORDING THIS DEED. THIS EXCLUSIVE RIGHT INCLUDES THE RIGHT OF GRANTOR TO MANAGE AND OVERSEE CONSTRUCTION BY ANY OTHER CONTRACTOR OR SUBCONTRACTOR DESIGNATED BY GRANTOR

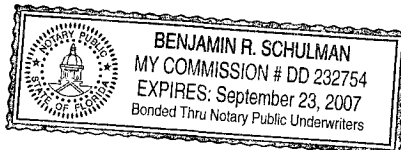
