CORRECTIVE PERSONAL REPRESENTATIVE'S DISTRIBUTIVE DEED

This deed is recorded to correct that certain deed recorded at OR Book 2008, Page 2342, public records of Citrus County, Florida, to add the description of the mobile home situated on said property.

THIS INDENTURE is made this 13th day of July, 2006, by and between Robert Sappenfield and Ronald Sappenfield, as co-personal representatives of the estate of Marjorie L. Kotwica, deceased, the tax identification number for which is [REDACTED] party of the first part, and Ronald Sappenfield, a single man, whose post office address is 7831 West Badger Lane, Dunnellon, Florida 34433, party of the second part.

WITNESSETH: That WHEREAS, Marjorie L. Kotwica died testate a resident of Citrus County, Florida, on January 15, 2002, seized and possessed of the real property hereinafter described; and

WHEREAS, title to said property passed to the party of the second part as of the date of said decedent's death pursuant to the decedent's Last Will and Testament, which was admitted to probate and recorded by the Circuit Court for Citrus County, Florida, Probate Division, in Case No. 2005-CP-1577, subject only to the right of the party of the first part to sell or encumber the property for the purpose of defraying claims, costs, and expenses of administration of decedent's estate; and

WHEREAS, the party of the first part wishes to distribute said property to the party of the second part and evidence of release of the property from said right to sell or encumber,

NOW THEREFORE, in consideration of the foregoing and in connection with the distribution of the estate of said decedent, the party of the first part hereby releases to the party of the second part the right to sell or encumber said property and hereby grants, conveys, and conforms unto the party of the second part, her heirs and assigns forever, all of the interest of said decedent in and to the real property situated in Citrus County, Florida, described as follows:

Lot 10, of BADGER ACRES, an unrecorded subdivision, being more particularly described as follows:

Commence at the NE corner of Lot 324, Plat of the Townsite of Citronelle as recorded in Plat Book 1, page 15, public records of Citrus County, Florida, thence S 89° 18' 25" W along the South right-of-way line of Orange Street, as shown on said plat, a distance of 215.05 feet to the Point of Beginning; thence continue S 89° 18' 25" W along said right-of-way line a distance of 100.01 feet, thence South 228.93 feet, thence East 100.00 feet, thence North 230.14 feet to the Point of Beginning.

SUBJECT to an easement across the South 15 feet thereof for road right-of-way and utility purposes.






Because this deed is given to evidence the distribution of assets of a decedent's estate and involves the assumption of no mortgage, minimum state documentary stamps are affixed.






