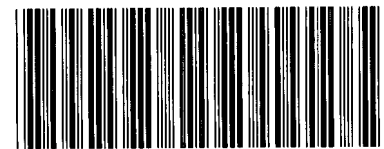

CORRECTIVE TRUSTEE'S DEED

This Corrective Trustee's Deed is executed and recorded to correct the name of the Sauder Family Trust referenced in that certain Trustee's Deed recorded in O.R. THIS INDENTURE made this 13 day of March, 2013, by FARMERS & MERCHANTS STATE BANK OF BUSHNELL as Trustee of the Sauder Family Trust No. One dated February 25, 1983, Grantor, and GREGG WILLIAM SAUDER a/k/a GREG WILLIAM SAUDER and LISA KAY SAUDER, as joint tenants with right of survivorship, Grantees, whose address is 184 Brighton Court, Safety Harbor, Florida 34695.

WITNESSETH:

THAT the Grantor, for and in consideration of the sum of Ten Dollars (\$10.00), to it in hand paid by the said Grantees, the receipt whereof is hereby acknowledged, has granted, bargained and sold to the said Grantees, the following described land, situate, lying and being in the County of Citrus, State of Florida, to-wit:

All that part of the East 330 feet of Government Lot 2 of Section 28, Township 18 South, Range 17 East, lying South of the Lagoon as shown on the plat of SUNSET SHORES as recorded in Plat Book 2, Page 140, Public Records of Citrus County, Florida.

SUBJECT to easements, covenants and restrictions of record.

SUBJECT to taxes for 2013 and subsequent years.

SUBJECT property is not the homestead property of the named Grantor.

THIS IS A DEED OF GIFT WITH NO CONSIDERATION IN EXCESS OF \$100.00 PASSING.

AND it is expressly understood and agreed between the parties and all successors and assigns that this Trustee's Deed is delivered from the Grantor, not personally, but as Trustee of the Sauder Family Trust No. One dated February 25, 1983, in exercise of authority conferred upon such Trustee therein. No personal liability or responsibility is assumed by or shall be enforceable against said Trustee, either express or implied.
